The *RRPE* publishes three different types of reviews:

- Reviews of individual books, both books on the following list that have been received from publishers, as well as books not on this list that are related to radical political economics. These reviews should be 1500–2000 words in length.
- Review essays encompassing three or four books that bring together an important literature in significant areas for political economists. These reviews should be 2500–3500 words in length.
- Ambitious examinations of bodies of literature that should be better known by *RRPE* readers. These reviews should also be 2500–3500 words in length.

Please contact the *RRPE* book review editor, Fletcher Baragar, for assistance in obtaining review copies of books. More detailed instructions will accompany the book when it is sent.

RRPE book reviews are blind peer-reviewed by the book review editor and one other member of the Editorial Board.

Reviews should be submitted within sixty days of receipt of the book. All reviews should be submitted online through the *RRPE* Manuscript Central website, <http://mc.manuscriptcentral.com/rpe>.
